Bruce Redman reported that our website domain name payment is due in July. The cost is approximately \$60-\$70 per year. This is in the approved 08-09 budget for 2 years. We do not have to pay a hosting fee any longer due to the Mountain View Athletic Association website now in operation.

As a booster club, we will be distributing committee signup opportunities as well as information sheets. Darin handed out the proposed Mountain View Football Boosters Membership Application. There was much discussion and it was decided that we will proceed with this program. It will be discussed at the meeting on Monday so parents will have a heads up on what their involvement can be.
